By an earlier definition, cumulative impact is “exclusive of that local disruption that can be ascribed to a specific change,”<sup>1</sup> or stated another way, cumulative impact cannot be ascribed to a specific change.

## **Proving the Cause-Effect Linkage**

Cumulative impact is the unforeseeable disruption of productivity resulting from the “synergistic” effect of an undifferentiated group of changes. Cumulative impact is referred to as the “ripple effect” of changes on unchanged work that causes a decrease in the productivity and is not analyzed in terms of spatial or temporal relationships.
