### Michigan Court Rules - Current

If your complaint is that somebody seeking your criminal record from the Michigan State Police will see that you were charged with a crime (e.g., domestic violence) and that the charge was dismissed, the destruction of your fingerprints and arrest card (assuming they weren't destroyed automatically) won't change that state record.

Thankfully, there is a way to get dismissed charges removed from your criminal record. This is called "expungement." To expunge something means to "remove it completely." In literal terms, this is the court process by which your criminal record is destroyed.

### Do Dismissed Charges Show up on a Criminal Record?

Submit the applicant fingerprint card (RI-8), the application form from the court (MC227 or JC66), a certified copy of the judgment of sentence, probation order, or register of actions, and a \$50.00 (\$30.00 juvenile set aside) processing fee in the form of a money order or check made payable to the State of Michigan.

### Obtaining an Expungment: Removing A Criminal Charge from ...

By showing the lack of probable cause, the court may drop or dismiss the charges. Mistakes in the criminal complaint — When the police officer is writing the criminal complaint or charging documents, he/she must sign the document under oath. Michigan and local laws state the specific ways that officers must write a complaint or charging document.

### How to Get Criminal Charges Dropped or Dismissed ...

In Michigan, if you are arrested or charged with a felony or certain misdemeanors your fingerprints and biometric information are entered into a system known as the Internet criminal history access tool (ICHAT). ICHAT aggregates criminal records and is used by employers and others to conduct background checks.

### Criminal Charge Dismissed? What Happens to the Arrest ...

A conviction for a non-traffic offense reportable to the Secretary of State may be set aside by the court, however, the court cannot order the removal of the conviction from your driving record. ### Crimes Eligible for Expungement in Michigan :: Criminal ...

The delay between the crime date and the defendant's arrest on an authorized charge can take any length of time (e.g., if the defendant's whereabouts are unknown, or if the defendant has left the State of Michigan).
